General Manager Dan York (GM York) wished all a Happy New Year.

Board Vacancy

1. Division 2 Board Vacancy Interview Process

GM York introduced the item.

William Eubanks (Mr. Eubanks) inquired why the Board decided to appoint a Director, as opposed to holding a Special Election, and encouraged the Board to find a candidate that was interested in water.

President Locke joined the meeting at 4:41 p.m.

Board discussion ensued over the process of conducting interviews for the 13 candidates that have provided their letters of interest and resumes.

The Board agreed to interview all 13 candidates, in alphabetical order, at the Special Board Meeting on January 5, 2022, at 4:30 p.m.

The Board agreed to assign a time for each candidate to join the meeting for their interview.

The Board agreed to allow 10 minutes for each candidate to answer predetermined questions, as well as tell the Board about themselves.

The Board agreed to send an email to each candidate on Thursday, December 30, 2021, with the predetermined questions, as well as the interview instructions.

The Board agreed to the following questions:

- Why do you want to be on the Board?
- What do you bring to benefit the Board?
- Do you have any experience with being on any other Boards?
- Is there anything else you want to add?

The Board agreed to have the Board President review the final questions and instructions for staff to send to each candidate.

The Board additionally agreed that once each candidate's presentation was over, they would be invoted to sit in the audience if they chose.

The Board agreed that following all interviews on January 5, 2022, each Director would select their top two candidates. Once selected, those candidates would be contacted and asked to attend the meeting on January 10, 2022, at 4:30 p.m., for additional questions from the Board.

The Board agreed that following the final interviews on January 10, 2022, the Board would appoint a new Director for Division 2.

Mr. Eubanks commented on Agenda Item's 2 and 3, expressing he felt very highly of GM York's performance, and noted he felt GM York brought a lot of experience and clarity to the operation of this District, which, he felt was outstanding.
