Governance and Representation

Board of Directors

- Begin with 11 directors from both districts
- Draft voting division maps to consider community interests, geography, topography
- Extensive review: public, legal, Sacramento County Registrar, special Board meetings
- Potential for greater influence
- Tentative Decision: Transition to 7 directors by 2026
 - Avoid multiple elections

Non-Residential Customers	\$343.94	\$339.36
Fixed/Variable Charges	Typical 1-inch residential customer pays 55% fixed charge and 45% usage charge	All rates are constructed at 69% fixed charge and 31% usage charge

Rates and Financial Considerations

Current Debt and Debt Service

	CARMICHAEL WATER DISTRICT	SACRAMENTO SUBURBAN WATER DISTRICT
Outstanding Debt	\$32,508,528 or \$2,795 per account	\$54,915,515 or \$1,212 per account
Annual Debt Service	approximately \$2,500,000 or \$215 per account, fully amortized in 2038	approximately \$7,000,000 or \$154 per account, fully amortized in 2031

Rates and Financial Considerations

Future Rate Structure with a Combined District

- Rates based on combined O&M and capital costs
- Anticipated initial (one-time) costs expected to be offset by future savings
- Potential for greater rate and financial stability
- Potential for lower rate increases over time





Rates and Financial Considerations

Liability for Debt Management

- LAFCO mandate: Each agency responsible for its debt
- Rates remain separate until debt retired—subject to reassessment
- Continued debt repayment—potential reassessment for lower interest rate
- Larger rate base viewed favorably by rating agencies





Rates and Financial Considerations

Liability for Infrastructure

- Similar infrastructure condition
- LAFCo role: Ensures one district's debt not transferred
- Larger organization better positioned to invest in infrastructure improvements





Water Quality

Fluoride

- SSWD's South Service Area fluoridated until 2027
- No mandate to continue fluoridation post-agreement
- No mandate for CWD to fluoridate water

Water Source

- Combination not expected to change water quality
- Carmichael customers would receive the same surface water, unless curtailed





Water Supplies and Rights



Supply Reliability

- Combination enhances supply reliability, especially during droughts
- Currently, both can meet demands; but challenged by climate change and regulations
- CWD faced recent water rights curtailments
- Integration opportunities for a more diverse, adaptable supply



Water Supplies and Rights



Supply Portfolio

- SSWD and CWD would share rights to surface water and groundwater
- Promotes a sustainable, reliable operation
- Clarify: Right does not equal delivery—constrained by infrastructure
- CWD would maintain historical access to surface water



Model Merged District (Type of District)

County Water District vs. Irrigation District

- CWD: Irrigation District—water, drainage, electric power, sewer services
- SSWD: County Water District—water, wastewater, fire protection, solid waste services
- More similarities than differences
- Tentative Decision: County Water District
 - Aligns with operational needs and minimizes costs





Model Merged District (Type of District)

Consolidation vs. Reorganization

- Both have advantages and disadvantages:
 - Consolidation: new entity, fresh start, opportunity to streamline
 - Reorganization: continuity, more complex operational integration, and public education
- Tentative Decision: Consolidation
 - Fresh start and new identity



Opportunities for Employees



Career Growth and Representation

- May aid in retention of employees at both districts
- Expanded career prospects and economies of scale for compensation and benefits
- New opportunities for specialization and advancement
- Some CWD employees represented by AFSCME: Continuation subject to majority vote



Benefits to Combination

- Enhanced water supply reliability
- Long-term financial savings and stability
- Economies of scale and efficiency
- Opportunities for staff retention, growth and shared expertise
- Greater influence for expanded service area
- Infrastructure improvements


